

**From the Pastor:**

James 4:11-12 reads, “Do not speak evil of one another, brethren. He who speaks evil of a brother and judges [Greek – krino] his brother, speaks evil of the law and judges [Greek – krino] the law. But if you judge [Greek – krino] the law, you are not a doer of the law but a judge. There is one Lawgiver, who is able to save and to destroy. Who are you to judge [Greek – krino] another?”

In the Greek there are several words that are translated as “to judge” and “judgment.” Krino is one of the words that is translated as “to judge.” But, like many words, it has more than one meaning. Danker’s Lexicon gives the following meaning for krino in relation to its use in James 4:11-12: Krino means to “Pass an unfavorable judgment upon” in other words to “criticize, find fault with, condemn.” From the context of James 4:11 that definition appears to be accurate since James said, “Do not speak evil of one another, brethren.”

Question: How does speaking evil of your brother and judging [criticizing] your brother, speak evil of the law and criticize the law? What does the law say? We read in Leviticus 19:18, “You shall not take vengeance, nor bear any grudge against the children of your people, but you shall love your neighbor as yourself: I am the Lord.” So when we speak evil of our brother we are criticizing the law that says we should be loving our neighbor.

Speaking evil of [criticizing, finding fault with or condemning] a brother is not of God. The apostle John put this understanding this way in 1 John 4:20-21, “If someone says, ‘I love God,’ and hates his brother, he is a liar; for he who does not love his brother whom he has seen, how can he love God whom he has not seen? And this commandment we have from Him: that he who loves God must love his brother also.”

As we approach the Passover, we must be sure that we are not harboring ill feelings toward anyone who is a brother—any who are members of the body of Christ. It is the real bond of love that is to identify us as the disciples of Jesus Christ. John 13:35 records, “By this all will know that you are My disciples, if you have love for one another.”

James said to speak evil of a brother is judging his brother; and, thus is speaking evil of the law and judging the law. He then said to be doing this such a person has ceased being a doer of the law but has set himself up as a judge of the law. What is James saying?


We must understand that we can and do recognize when someone’s actions are contrary to what God says. Don’t we? But, all too often this simple act of right “judging” does not stop there. Too often we impute motives as to why this act was done. We too often conclude what must have been in their heart that led them to do what we saw. This is wrong for we cannot see what the actual motivation of their heart was—only God can do that. Therefore, if we feel what we saw must be dealt with, we must go to that person [alone] and express what we saw—explaining that we may have read the situation wrongly, but, that they may wish to understand how what was done appeared.

To impute motives is setting ourselves up as a judge of someone’s heart. James 4:12 is showing that only God can truly judge for only He can see what the true motivation of one’s heart is.
