From the Pastor:

The rest of James 5:15 reads, "And if he has committed sins, he will be forgiven." We must not conclude from this passage that all illness or injury involves sin. The verse reads, "And IF" denoting that sin is not always involved in illness. In times past some have assumed that illness occurred because some law was violated. This is not true. Illness and injury can occur to a person and he or she has not committed any sin which caused this physical problem.

However, some illnesses and/or injuries do involve sin. An example of this would be cirrhosis of liver as a result of prolonged alcohol abuse. So this statement in James is given from the point of view of an individual who may or may not have brought on his physical problems as a result of his sin.

If there was sin James is also clearly assuming that by the individual turning to God for healing, he has acknowledged and is repentant of his sin. Otherwise, his sin would not be forgiven. There must be a spirit and attitude of repentance before God will forgive sin. This is what Peter said in Acts 3:19, "Repent therefore, and turn to God SO THAT your sins may be wiped out..." (New Revised Standard Version – NRSV) There would be no forgiveness of sins if the individual had not first repented.

This is a good place to examine Jesus' encounter with the paralyzed man recorded in Matthew 9:2-7:

"And behold, they brought to Him a paralytic lying on a bed. And Jesus, seeing their faith, said to the paralytic, 'Son, be of good cheer; your sins are forgiven you.' And at once some of the scribes said within themselves, 'This Man blasphemes!' But Jesus knowing their thoughts, said, 'Why do you think evil in your hearts? For which is easier, to say, "Your sins are forgiven you," or to say, "Arise and walk?" But that you may know that the Son of Man has power on earth to forgive sin.'—then He said to the paralytic, 'Arise, take up your bed, and go to your house.""

Please don't forget that Jesus, as the Word (a member of the Godhead) in the flesh, had the same capabilities of mind that He had when we was on the God-plane level of life. He saw what was in the minds of the scribes ("Jesus knowing their thoughts"). Jesus also knew that this individual's paralysis was due to a sin he had committed. Otherwise, his healing would not have involved a forgiveness of sin. This particular healing was not preceded by the individual's repentance. Why? This was a special case for the purpose of showing the authority Jesus had. "But that you may know that the Son of Man has power [authority] to forgive sins…"

"Power" is from the Greek "exousia." It is translated as "authority" 29 times in the KJV. The OBGL makes this comment, "primarily liberty of action" and "liberty of doing as one pleases." Jesus had the authority to do as He pleased. He healed this man by forgiving his sins to show He had the authority to forgive sins.

Not all illness is as a result of sin. However, if it is, God will heal if we repent of those sins.
